

Birch Rock Camps Grand Centennial Celebration

Code of Conduct and Waiver/Release of Liability

The following provisions are designed to ensure that the Birch Rock Camp Grand Centennial Celebration Weekend is a happy, safe, and productive experience for everyone. By registering for the Weekend, you are agreeing to adhere to our Code of Conduct and Policies and the Waiver/Release of Liability.

You will be asked to affirm your agreement to abide by this Code and to be legally bound by the Waiver/Release of Liability by signing this form upon check-in for the Weekend.

General Policies

1. All attendees must be 18 years of age or older unless accompanied by a parent or guardian.
2. Parents or guardians are responsible for the care and supervision of their children (17 and under).
3. Please leave your pets at home.

Drugs and Alcohol

1. Since the Grand Centennial Celebration Weekend is designed to be a family friendly event, the alcohol policy is as follows:
Alcohol will be served at Friday and Saturday evening Salty Snacks and dinner functions, to be consumed by those of legal drinking age (21 and older). There is to be no use of alcohol in other places on the Birch Rock property, including the waterfront. Guests may be asked to show ID to the bar staff serving alcohol. Bringing outside alcohol to the tent and the surrounding parking area is not allowed. Everyone is expected to consume responsibly, and at all times to respect camp property, staff and all event participants.
2. No person may provide alcohol to any attendee under the age of 21.
3. The use or possession of marijuana or any other controlled substances or drugs is not permitted at camp.
4. To maintain the Birch Rock Camp clean living atmosphere, please refrain from smoking or vaping at camp.

Safety and Health

1. Weapons of any description, fireworks, and any other incendiaries are not permitted in camp.
2. Camp and event staff have authority in each respective activity area. Participants at these areas are expected to adhere to the specific rules of each area and to all directions of event staff.
3. Staff lifeguards will be on duty at waterfront during designated activity periods. The use of Birch Rock watercraft and docks can only be used at these times when staff is present and with express permission of staff who are present. Swimming at the Birch Rock waterfront outside these designated coverage times is at your own risk. Notwithstanding the presence of lifeguards or other staff, parents or guardians will be fully responsible for directly supervising their children while swimming or boating.

Waiver and Release of Liability

1. By signing this Waiver and Release of Liability (Agreement), I waive and release Birch Rock Camp, its agents, servants, employees, insurers, successors and assigns (collectively, "Camp Representatives") from any and all claims, demands, causes of action, damages or suits at law and equity of any kind, including but not limited to claims for personal injury, property damage, medical expenses, loss of services, on account of or in any way related to or growing out of my presence or involvement at the facility.

This waiver and release is intended to and does release Birch Rock Camp and all Camp Representatives from any and all liability for damages or injuries on account of or in any way related to or growing out of my negligence, the negligence of third parties and/or Birch Rock Camp's or a Camp Representative's negligence or gross negligence. This Waiver and Release of Liability is not intended to release or waive any liability resulting from willful misconduct.

I further covenant and agree not to institute any claims or legal action against Birch Rock Camp for any claim released or waived by this Agreement. I further agree that should any claim be made against Birch Rock Camp or any Camp Representative in contravention of this Agreement on behalf of me, my children, my estate or my family, I and my personal representatives will protect, defend and completely indemnify (reimburse) Birch Rock Camp and the Camp Representatives for any such claim and expenses including attorney's fees and costs.

2. I understand that Birch Rock Camp is not responsible for any lost, stolen, or damaged valuables or property.
3. I acknowledge that I have received and read a copy of the above rules and regulations governing the use of the facility. I agree that I will fully comply with all rules and regulations and with any amendments.

I have read the Agreement and understand that by signing the Agreement I have consented to be bound by its terms, including the waiver/release of any legal right I and my personal representatives may have to sue Birch Rock Camp and the Camp Representatives for any costs they incur because a claim or legal action is brought in violation of this Agreement. I agree any violation of the Code of Conduct set forth in this Agreement, as determined by Birch Rock Camp and its representatives in their discretion, will entitle Camp to require me and my family to leave Camp prior to the conclusion of the Grand Centennial Celebration Weekend.
